## MARSHAN TOWNSHIP MEETING March 20, 2012

The March, 2012 meeting of the Marshan Town Board was called to order by Chairman Jerry Bauer at 8:04 P.M. Others present were Joe Birk, Jim Wollmering, Marge Snyder and John Maher.

Minutes from the February 21<sup>st</sup>, 2012 Town Board Meeting was read. Motion by Jim Wollmering and seconded by Joe Birk to approve as read. Motion carried unanimously.

Minutes of the planning commission meeting held on March 6<sup>th</sup>, 2012 were read. Motion by Joe Birk and seconded by Jim Wollmering to approve as read. Motion carried unanimously.

### **Old Business:**

Ron Wasmund from Inspectron Inc. appeared to report on the businesses in the township without permits. He has sent out several letters and is waiting for replies.

### **New Business:**

The Dakota County sheriff appeared. He reported on 2 different robbery's in the township today. This is the time of the year these things can happen so residents should make sure they lock their doors and vehicles. The board asked him to check on the weight limits on township roads.

Jake Marthaler of 2075 Highland Dr., Hastings appeared asking for a permit for an addition to the home he just purchased on 21356 Nicolai Ave. This addition is approximately 800 sq. ft. Motion by Jim Wollmering and seconded by Joe Birk to approve this addition. Motion carried unanimously.

Motion by Jim Wollmering and seconded by Joe Birk to hire Quality Propane to put the dust control on the township roads. This would be the first application. Motion carried unanimously.

Motion by Joe Birk and seconded by Jim Wollmering to adopt the resolution to reestablish our precincts and polling place. Motion carried unanimously.

Motion by Jim Wollmering and seconded by Joe Birk to approve the joint powers agreement between the Hastings Rural Fire association and Marshan Township. Motion carried unanimously.

Motion by Jim Wollmering and seconded Joe Birk to adopt the resolution for the Records Retention and Filing System for Townships from the Minnesota Historical Society. Motion carried unanimously.

Treasurer's report was read. Motion by Joe Birk and seconded by Jim Wollmering to approve the Treasurers report as read and printed. Motion carried unanimously.

Motion by Jim Wollmering and seconded by Joe Birk to leave the meeting open until March 31<sup>st</sup> for the supervisors to check the roads. Meeting was then closed on March 31<sup>st</sup>, 2012 at 12 noon.
