## MARSHAN TOWNSHIP MEETING

The March 17, 2015 meeting of the Marshan Town Board was called to order by Chairman Jerry Bauer at 8:05 P.M. Others present were Jim Wollmering, Gloria Pinke, John Maher and Marge Snyder.

Minutes of the February 17, 2015 Town Board meeting were read. Motion by Pinke and seconded by Wollmering to approve and place on file. Motion carried unanimously.

Minutes of the March 3rd, 2015 Planning Commission meeting were read. Motion by Wollmering and seconded by Pinke to approve and place on file. Motion carried unanimously.

Swearing in of new officers. Filled out Oath of Office forms.

### **Old Business:**

Mr. Wasmund was not able to attend this meeting. He was able to send a report, this report is attached.

### **New Business:**

Mr. Bruce Hemingson, of 12775 190<sup>th</sup> Street appeared to request a permit for an 18'x20' addition to their home. All set backs are able to be met. Motion by Wollmering and seconded by Pinke to approve this permit. Motion carried unanimously.

Mr. Larry Schlomka, of 17560 Northfield Blvd. appeared asking to tear down 4 out buildings with 1920 square feet. He would like to replace these buildings with one building 40'x48'. This building would be for personal use. He is not able to meet set-backs, so he will need written permission from his closet neighbors. He was also requested to get a site map of the property. Motion by Wollmering and seconded by Pinke to approve pending approval from adjoining property owner and a site map. Motion carried.

Alan Swanson appeared asking about the property in Sec. 23 on 195<sup>th</sup> Street. He is asking if this property has a buildable lot. This 53 acre parcel is a lot of record and has been since 1954. Motion by Pinke that there is a buildable lot on parcel # 25-02300-50-011. Motion seconded by Wollmering. Motion carried unanimously.

Treasurer's report was given. Motion by Wollmering and seconded by Pinke to move the moneys from the Recreational CD to the General Checking Account. Motion carried unanimously.

Motion by Pinke and seconded by Wollmering to approve the treasurers report as read and printed. Motion carried unanimously.

Motion made by Pinke and seconded by Wollmering to appoint Jerry Bauer as Chairman of the Board. Motion carried unanimously.

Motion by Pinke and seconded by Bauer to adjourn the meeting. Meeting adjourned at 10:40p.m.
