MARSHAN TOWNSHIP MEETING May 15, 2012

The May, 2012 meeting of the Marshan Town Board was called to order by Chairman Jerry Bauer at 8:00 P.M. Others present were Joe Birk, Jim Wollmering, Marge Snyder and John Maher, and Attorney George May.

Minutes from the April 17th, 2012 Town Board Meeting was read. Motion by Jim Wollmering and seconded by Joe Birk to approve. Motion carried unanimously.

Minutes from the Planning Commission Meeting on May 1st, 2012 were read. Motion by Joe Birk and seconded by Jim Wollmering to approve. Motion carried unanimously.

Minutes from the three Public Hearings held on May 1st, 2012 were read. Motion by Joe Birk and seconded by Jim Wollmering to approve. Motion carried unanimously.

Old Business:

Ron Wasmond appeared to discuss the businesses in the township without permits.

New Business:

Eugene Bauer appeared to get approval of his IUP. A public hearing was held on May 1st, 2012. Motion by Joe Birk and seconded by Jim Wollmering to approve his IUP. Motion carried unanimously.

Steven Fox appeared to get approval of his IUP. A public hearing was held on May 1st, 2012. Motion by Joe Birk and seconded by Jim Wollmering to approve his IUP. Motion carried unanimously.

Randy Gilb appeared to get approval of his IUP. A public hearing was held on May 1st, 2012. Motion by Jim Wollmering and seconded by Joe Birk to approve his IUP. Motion carried unanimously.

Russell Mamer appeared requesting a permit to construct a pole building 60'x40'x12'. He also was requesting the set-back be reduced from normal set-backs to 16' on the west and 6' on the south. A note from the adjoining property owner, Helen Mamer, was presented indicating no objection to the reduced setback. Motion by Jim Wollmering and seconded by Joe Birk to approve this permit with the set-back reduction. Motion carried unanimously.

The Dakota county Sherriff appeared to ask if there were any concerns of the residence or board members. He reported that the Social Host ordinance has been passed.

Kathy Leifeld appeared asking for a resolution to approve the Miesville Lions Club to hold a one day temporary gambling permit. This was for a benefit for Kevin Peine Family. Motion by Joe Birk and seconded by Jim Wollmering to approve. Motion carried unanimously. Attached is a copy of this resolution.

Brandi Tracy appeared asking the Board to reconsider their decision which was made last

month. She explained about her rescue operation. She explained all that she does in the community. She was told she could not run a rescue operation; there is no ordinance in Marshan Township for a rescue operation. Brandi Tracy asked the board if they would consider writing an ordinance for a rescue operation. The Board told her they would not consider writing an ordinance for rescue.

Robby Fischer appeared asking questions about the property they are interested in purchasing.

Joe Harris appeared to ask the Board if they would approve and sign the Joint Powers Agreement between Dakota County and Marshan Township for Technical Assistance in Street Naming and Address Assignments. Motion by Joe Birk and seconded by Jim Wollmering to approve this agreement. Copy of the Agreement is to be attached to the minutes. Motion carried unanimously.

Mr. Harris also asked if the township needed anything else at this time.

Treasurer's report was read. Motion by Joe Birk and seconded by Jim Wollmering to approve the Treasurers report as read and printed. Motion carried unanimously.
