## MARSHAN TOWNSHIP MEETING July 17, 2012

Minutes from the June 19<sup>th</sup>, 2012 Town Board Meeting was read. Motion by Jim Wollmering and seconded by Joe Birk to approve. Motion carried unanimously.

Minutes from the Planning Commission Meeting on July 3<sup>rd</sup>, 2012 were read. Motion by Joe Birk and seconded by Jim Wollmering to approve. Motion carried unanimously.

## **Old Business:**

Ron Wasmond appeared to discuss the businesses in the township without permits. He presented a copy of a contractor application. This will be sent to the businesses that are just contractor who have some equipment, but don't run the business from their home.

## **New Business:**

Ted Wagner appeared for Wayne Larson on Lillihei to get a permit to rebuild his garage which was damaged with a tree falling on it from the storm. The garage will be the same size as before. Motion by Joe Birk and seconded by Jim Wollmering to approve. Motion carried unanimously.

Michele and Robbi Fischer appeared to get a building permit for a home 3218 sq. ft. with a 1800 sq. ft. attached garage. They also want a permit for an out building 54x74. Motion by Jim Wollmering, seconded by Joe Birk to approve contingent on they get the 2 two parcels combined before they get the permit from Mr. Wasmond, the building inspector. Motion carried unanimously.

Motion by Jim Wollmering and seconded by Joe Birk to approve the combining of the two properties' for them. Motion carried unanimously.

Brandi Tracy from Braveheart Rescue and Jan Kartel and some of her supporters appeared. They asked for a three month extension, until October 17, 2012. They said they have rescue groups who have agreed to take all of the Dogs, but they need more time to get all of them to their new homes. These shelters are not all in Minnesota. They have 14 dogs and 7 will leave in about 2 weeks and the rest within the 3 months. The board requested Brandi Tracy to appear at the October meeting to update the board on the progress. Motion by Joe Birk and seconded by Jim Wollmering to approve there request of a 3 month extension. Motion carried unanimously.

Brian Hillgartner of Bolton and Menk Inc. appeared to discuss the culvert on 205<sup>th</sup> street. He will appear at our next meeting with more information.

Treasurer's report was read. Motion by Joe Birk and seconded by Jim Wollmering to move \$29,818.10 from checking account to the Fire Fund, also to move \$47,260.95 from the Fire Fund to the Checking Account. Motion carried unanimously. Motion by Joe Birk and seconded by Jim Wollmering to approve the Treasurers report as read and printed. Motion carried unanimously.
