MARSHAN TOWNSHIP MEETING October 18, 2016

The October, 2016 meeting of the Marshan Town Board was called to order by Acting Chairman Gloria Pinke at 8:00 P.M. Others present were Jim Wollmering, Marge Snyder and John Maher.

Minutes of the September 20th, 2016 Town Board meeting was read. Motion by Pinke and seconded by Wollmering to approve and place on file. Motion carried unanimously.

Minutes of the October 4th, 2016 Planning Commission meeting was read. Motion by Wollmering and seconded by Pinke to approve and place on file. Motion carried unanimously

New Business

Mr. Tim Little of Rosemount, MN. and Kyle Dalton of Fridley, MN. appeared to propose a 3 to 5 year lease of the Angerman property. The purpose would be to bring to the property damaged cars and other vehicles to present to prospective buyers thru an online auction, with an occasional on site auction. They are also interested in purchasing the property if that is what the town board agrees that our ordinance will allow. The Board will contact the planner and the Township attorney to find out the next process. No action was taken at this time.

Dakota County sheriff appeared to ask if there are any questions or concerns. Some of the concerns of the public were the 4-wheelers in the area.

Mr. Tetzluff appeared inquiring about the cars on his neighbor's property. Mr. Wasmund was not at this meeting to give us an update on the findings.

Motion by Wollmering and seconded by Pinke to approve the renewal of the liquor, wine, club or 3.2% licenses for Hidden Greens Golf Course, Little Log House Properties Inc. and Bellwood Oaks Golf Course. Motion for all three was carried unanimously.

Motion by Wollmering and seconded by Pinke to approve the Cooperation agreement for the Dakota County Community Development Block Grant Program. Motion carried unanimously.

Motion by Pinke and seconded by Wollmering to approve land split for Matt Francis. This is to split 13.45 acres from his property for a buildable lot. A letter will be drafted for him to take to the County. Motion carried unanimously.

Motion by Wollmering and seconded by Pinke to approve the Joint Powers Agreement between the County of Dakota and Dakota County Townships & Cities for Administrative Services related to Municipal SSTS Pump Maintenance Programs. Motion carried unanimously.

Motion by Pinke and seconded by Wollmering to approve A Resolution Committing to Participation in the Dakota County Rural Collaborative Planning Process To Complete 2040 Comprehensive Plan Updates. Motion carried unanimously.

Treasurer's report was given. Motion by Pinke and seconded by Wollmering to approve the treasurers report as read and printed. Motion carried unanimously.

Motion by Wollmering and seconded by Pinke to adjourn the meeting. Meeting adjourned at 9:45p.m.
