MARSHAN TOWNSHIP MEETING

The June 21st, 2016 meeting of the Marshan Town Board was called to order by Chairman Jerry Bauer at 8:00 P.M. Others present were Gloria Pinke, Marge Snyder and John Maher.

Minutes of the May 17th, 2016 Town Board meeting were read. Motion by Pinke and seconded by Bauer to approve and place on file. Motion carried unanimously.

Minutes of the June 7th, 2016 Planning Commission meeting were read. Motion by Pinke and seconded by Bauer to approve and place on file. Motion carried unanimously.

Minutes of the June 7th Public Hearing was read. Motion by Pinke and seconded by Bauer to approve and place on file. Motion carried unanimously.

Old Business:

There was none.

New Business

Mark Frojd appeared for Collen Frojd of 18555 Michael Ave. for a permit for a 40x60 ft. building. They are able to meet all setbacks. This building will be used for storage and possible for a couple horses. Motion by Pinke and seconded by Bauer to approve. Motion carried unanimously.

Kris Cavanaugh, 19780 Lillehei, appeared for a permit to build a 40x60 ft. pole building. All setbacks are able to be met. He has a 10 acre parcel. This building will be used for personal storage. Motion by Bauer and seconded by Pinke to approve. Motion carried unanimously.

Dakota County Sherriff appeared asking if there were any problems or concerns in the area. They had nothing else at this time.

Jamie Schuster appeared for approval to hold a fundraiser for the Hastings Hockey boosters which will be held at Hidden Greens Golf Course on Sept 10th, 2016. She was also asking for a permit. Motion by Bauer and seconded by Pinke to approve her request. Motion carried unanimously.

Representatives from So-Core appeared asking for approval of the changes they requested to the ordinance and to their IUP. Much discussion was held on this. Motion was made by Bauer and seconded by Pinke to deny their request. Motion carried unanimously. The board plans to meet with the Township Attorney and Planner to discuss some of their issues with this request.

Motion by Bauer and seconded by Pinke to appoint Beau Stewart to the planning commission and accept a resignation from Pat Sajevic. Motion carried unanimously.

Motion by Pinke and seconded by Bauer to raise the fee for cleaning of the Town Hall to 50.00 for each cleaning. Motion carried unanimously.

Treasurer's report was given. Motion by Bauer and seconded by Pinke to move 125,000.00 from money market checking to the checking. Motion carried unanimously.

Motion by Pinke and seconded by Bauer to approve the treasurers report as read and printed. Motion carried unanimously.

Motion by Pinke and seconded by Bauer to adjourn the meeting. Meeting adjourned at 10:45p.m.
