Minutes of the May, 2017 Town Board meeting were read. Motion by Pinke and seconded by Bauer to approve and place on file. Motion carried unanimously.

Minutes of the Public Hearing of June, 2017 were read. Motion by Pinke and seconded by Bauer to approve and place on file. Motion carried unanimously.

Minutes of the special meeting of June, 2017 were read. Motion by Pinke and seconded by Bauer to approve and place on file. Motion carried unanimously.

Mr. Wasmund appeared to report on the Mellon and Miller cases. Progress is being made.

### **New Business**

The Dakota County Sheriff Mr. Timothy Gonder appeared to report on what is happening in the township. He reported that there have been a lot of unattached garage thefts. Also there has been a lot of burning without permits.

Mr. Al Swanson appeared for a permit for the 6400 sq. ft. club house at the Hidden Green Golf Course. A motion was made by Pinke to change the ordinance to allow golf courses as a permitted use. Mr. Dean Johnson will rewrite the ordinance to do this. Motion seconded by Bauer. Motion carried unanimously. Motion made by Pinke and seconded by Bauer to approve the building permit for the 6400 sq. ft. building. Motion carried unanimously.

Josh Horsch appeared of 21720 Inga Ave. to build a home on Kirby between 180<sup>th</sup> and 190<sup>th</sup> on the west side of road. PID # 25-01700-02-030. Motion by Pinke and seconded by Bauer to approve this permit. Motion carried unanimously.

Mr. Weis appeared about the purchase of the Angerman property. He was told the board would contact the planner to set a public hearing.

Treasurer's report was given. Motion by Pinke and seconded by Bauer to move \$80,000.00 from Money market to checking. Motion by Pinke and seconded by Bauer to approve the treasurers report as read and printed. Motion carried unanimously.
