MARSHAN TOWNSHIP MEETING February 21, 2017

The February, 2017 meeting of the Marshan Town Board was called to order by Chairman Jerry Bauer at 8:00 P.M. Others present were Gloria Pinke, Marge Snyder and John Maher.

Minutes of the January 17, 2016 Town Board meeting were read. Motion by Pinke and seconded by Bauer to approve and place on file. Motion carried unanimously.

Minutes of the planning Commission meeting of February 8th, 2017 were read. Motion by Pinke and seconded by Bauer to approve and place on file. Motion carried unanimously.

Old Business:

Ron Wasmund of Inspectron appeared and reported on the Mellon Property. He has not heard from them at all, so he will contact the attorney to proceed to the next step. He also reported on the Miller property and also he will contact the attorney to proceed to the next step.

New Business

Dakota Co. Sherriff appeared to report on the activity in the Township. There was nothing new at this time.

Mr. John Kane appeared asking for a permit for a new home with 1488 sq. ft. and an out building of 40x 60' stick frame. The out building will be used for personal storage. He was able to meet all setbacks. The PID # is 25-02900-51-011. Motion was made by Pinke and seconded by Bauer to approve the building permit for the home. Motion carried unanimously. Also Motion by Pinke and seconded by Bauer to approve the permit for the out building. Motion carried unanimously.

Mr. Bob Denoyer of 15325 190th Street E. appeared asking for a permit for an addition to his home. He wants to build this addition 6 ft. closer to 190th street than the ordinance requires. He has contacted the County asking if the 6ft. was a concern to them and they had no problem with the 6 ft. Motion by Bauer and seconded by Pinke to approve the permit for the addition and also for the 6ft closer setback to 190th Street. Motion carried unanimously.

Jake Marthahler appeared to ask for a permit for a photography business at their home. He has filled out a permit application for an IUP. The clerk will send this application to the planner Mr. Dean Johnson for review and then a public hearing will be set.

Motion by Pinke and seconded by Bauer to approve the renewal Application for Mineral Extraction for Midwest asphalt corporation. Motion carried unanimously.

Treasurer's report was given. Motion by Pinke and seconded by Bauer to approve the treasurers report as read and printed. Motion carried unanimously.

Motion by Pinke and seconded by Bauer to adjourn the meeting. Meeting adjourned at 10:20p.m.
