MARSHAN TOWNSHIP MEETING April 17, 2018

The April, 2018 meeting of the Marshan Town Board was called to order by Chairman Jerry Bauer at 8:00 P.M. Others present were Gloria Pinke, Beau Steuart, Marge Snyder and John Maher.

Minutes of the March, 2018 Town Board meeting were read. Motion by Pinke and seconded by Steuart to approve and place on file. Motion carried unanimously.

Minutes of the April Planning Commission meeting were read. Motion by Pinke and seconded by Steuart to approve and place on file. Motion carried unanimously.

Minutes of the 2 public hearings were read. Motion by Steuart and seconded by Pinke to approve and place on file. Motion carried unanimously.

Old Business

Mr. Wasmund reported on the Mellon case. This is still being worked on.

New Business

Motion by Steuart and seconded by Pinke to approve the Variance for the Niem Phat Buddhist Temple. A public Hearing was held on the variance @ 7p.m. tonight by the Board of Supervisors. Motion carried unanimously.

The CUP conditions were read for the public to here for the Niem Phat Buddhist Temple. A public hearing was held on this on April 3rd, 2018. The Board chose to change several of the conditions in the CUP. The public's comments were heard. Chad Brown appeared for a permit to build a new home on the property on 160th St. this property is on the corner of Marshan Township and Vermillion Township. He is able to meet all set-backs. Motion by Steuart and seconded by Pinke to approve. Motion carried unanimously.

Discussion on the IUP for Mr. Mike Miller. Motion by Pinke to table this decision until the May 15th meeting as Mr. Miller is to come in compliance with the Township ordinance by May 1st. Also Mr. Miller was not present at tonight's meeting. Motion seconded by Steuart. Motion carried unanimously.

Motion by Pinke and seconded by Bauer to change the Town Board wages from \$95.00 to \$100.00 per meeting and no mileage will be paid for regular meetings.

Motion by Pinke and seconded by Steuart to appoint Jerry Bauer as Chairman. Motion carried unanimously. Motion by Bauer and seconded by Steuart to appoint Gloria Pinke as Vice Chair. Motion carried unanimously.

Motion by Pinke and seconded by Steuart to approve the treasurers report as read and printed. Motion carried unanimously.

Motion by Pinke and seconded by Steuart to adjourn the meeting. Meeting adjourned at 11:00p.m.
