MARSHAN TOWNSHIP MEETING May 15, 2018

The May, 2018 meeting of the Marshan Town Board was called to order by Chairman Jerry Bauer at 8:00 P.M. Others present were Gloria Pinke, Beau Steuart, Marge Snyder and John Maher.

Minutes of the April, 2018 Town Board meeting were read. Motion by Pinke and seconded by Steuart to approve and place on file. Motion carried unanimously.

Minutes of the May Planning Commission meeting were read. Motion by Pinke and seconded by Steuart to approve and place on file. Motion carried unanimously.

Old Business

Mr. Wasmund reported on the Mellon case. The attorney, Mr. Robert Alsop also appeared with a resolution to approve the settlement agreement in the Matter of Marshan Township V. SKINS Properties, LLC. Motion by Pinke to approve and sign resolution # 2018-1 and the Settlement Agreement, order and judgment as presented with the amendment extending the sig date by the defendant within 10 days. Motion seconded by Steuart. Motion carried unanimously.

New Business

Kathy Leifeld appeared to inquire if they have a buildable lot. PID # 25-01800-25-014. She was told this property is a buildable lot.

Mr. Miller appeared for a decision on the IUP application. He does not have the entire cleanup done at this time. The Township received a request by the Millers in writing to delay action until the June 19th meeting. This request was signed by both parties. Motion by Pinke to approve the delay, seconded by Steuart. Motion carried unanimously.

Russ Sobiech of DLR appeared asking about a variance for a building 7200 square foot. This building is for a storage building on the north side of the DLR property. He gave the board an application for a variance and an IUP. He also presented a check for the \$600.00 fee.

Mr. Cao of the Buddhist Temple appeared for his signed copy of the CUP and Variance. It was signed and notarized, and copies were given to Mr. Cao.

Motion by Pinke and seconded Steuart to approve the application for an Assemblage License for Little Log House Pioneer Village. The date of the event will be July 27-29, 2018 Motion carried unanimously.

Motion by Pinke and seconded by Steuart to approve Resolution #2018-2 approving the draft Dakota County Rural Collaborative 2040 Comprehensive Plan for Affected Jurisdiction and Metropolitan Council Review and Authorizing Housekeeping Amendments to the Plan. Motion carried unanimously.

Motion by Pinke and seconded by Steuart to approve Resolution #2018-3 adopting the Vermillion River Watershed Joint Powers Organization Watershed Management Plan as the

Local Water Management Plan within the Vermillion River Watershed. Motion carried unanimously

Motion by Pinke and seconded by Steuart to approve the treasurers report as read and printed. Motion carried unanimously.

Motion by Pinke and seconded by Steuart to adjourn the meeting. Meeting adjourned at 10:25p.m.
