MARSHAN TOWNSHIP MEETING May 21, 2019

The May meeting of the Marshan Town Board was called to order by Jerry Bauer. Others present were Beau Steuart, Gloria Pinke, Marge Snyder and John Maher.

Minutes of the April 16, 2019 Town Board meeting were read. Motion by Steuart and seconded by Pinke to approve with corrections and place on file. Motion carried unanimously.

There were no minutes from the Planning Commission.

Old Business: There was none

New Business:

Gene Kieffer of 19380 Lillehei appeared to asking to change his permit for his building to 1440 sq. ft. His original permit was approved in August of 2018. He is able to meet all setbacks. Motion by Steuart and seconded by Pinke to approve the change. Motion carried unanimously.

Ed Kranz of 20911 Joan Ave. appeared asking for a variance to build a building closer to the side property than the ordinance allows. He also asked for a building permit for a 40x60 pole barn. This building is for personal use. He wants to build this building 6 ft. from the side property. He has written permission from the owner of the adjoining property. Motion by Pinke to approve this as there is no other place to build on his property and he has a letter from the owner of the adjoining property. Motion seconded by Jerry Bauer. Motion carried with 1 nay.

Mike Slavik the commissioner appeared to update the board on the ground water plan. A workshop will be held on May 22 in Hastings. There will be other workshops coming up. He also updated on the road improvements which are coming in 2020 on 190th and Goodwin also on 190th and county 47.

Nan Baily appeared. She is petitioning to have a new culvert put in on 180th St. she would like 2- 36" culverts put in. The board told her there will be culverts put in sometime this year. Motion by Pinke to ask the soil and water for advice on the water flow, seconded by Steuart. Motion carried unanimously.

John and Bea Kingston appeared to ask if they have a buildable lot on PID# 25-02200-55-011. It was divided in 1991. This is after the date of 1-1-1980 so it would not have another building site. They were also inquiring about PID #25-02700-25-014, They thought it

was divided in 1975 or 79. They will check on these and will come back to another meeting.

Steve Marthaler appeared asking if he has a building site on his property PID# 25-01900-01-012. Motion by Stewart and seconded by Pinke that they do have a buildable lot there. Motion carried unanimously.

Arik Connell appeared asking questions about his property.

Hidden Greens has put up a sign on Hwy 61. It does not meet any of the ordinances in article 10 of the ordinance. The Clerk will send a letter to them

Treasurers Report was given. Motion by Pinke and seconded by Steuart to approve the Treasurers report as read and printed. Motion carried unanimously.

Motion by Steuart and seconded by Pinke to adjourn meeting. Meeting closed at 10:50p.m.
