## MARSHAN TOWNSHIP MEETING August 20, 2019

The August meeting of the Marshan Town Board was called to order by Jerry Bauer. Others present were Beau Steuart, Gloria Pinke, Marge Snyder and John Maher.

Minutes of the July 2019 Town Board meeting were read. Motion by Pinke and seconded by Steuart to approve and place on file. Motion carried unanimously.

Minutes of the August 6<sup>th</sup> planning commission meeting and the public hearing were read. Motion by Steuart and seconded by Pinke to approve the minutes as read and place on file. Motion carried unanimously.

**Old Business:** There was none

### **New Business:**

Mrs. Besler appeared with a complaint about her neighbor. Says they bring in large piles of debris and burn it. It smells and the smoke comes there way. According to Marshan Township ordinance #817 this is not allowed. Motion by Pinke to send a letter to Mr. Fritz asking him to come to the town board and discuss the burning problem. Motion seconded by Steuart. Motion carried unanimously. A copy of the complaint letter is attached. Motion by Steuart and seconded by Pinke to not allow Mr. Fritz any burning permits until further notice. Motion carried unanimously.

Chris and Stacia Quiring appeared asking to split 5.10 acres from James and Sandra Carroll's property. Motion by Pinke to approve the land split of PID # 25-0260026-013. Motion seconded by Steuart. Motion carried unanimously.

Joe and Jennie Slattery appeared to build a storage building on their property. Motion by Steuart for them to go back to the planning commission to determine where the building should be located. Motion seconded by Pinke. Motion carried unanimously.

Midco appeared asking about the board signing the franchise granting Midcontinent Communications to maintain a cable communications system in Marshan Township. Motion by Steuart and seconded by Pinke to approve the franchise. Motion carried unanimously.

Stewart recommended compiling a list of offsite signs and sending them a letter to permit them. The board would like to try to do this by next month.

Leah Johnson of MN Solar sent an e-mail asking what they need to put a Solar panel on a residential property located at 17729 Michael Ave. The board said they need a site plan and specks of equipment. Also the property owner and the Solar Co. should attend the planning commission meeting on Sept. 3<sup>rd</sup>.

Motion by Steuart and seconded by Pinke to not pay the Northern Salt bill and to contact them asking for an explanation of this bill.

Motion by Steuart and seconded by Pinke to move 50,000 from CD to the Money Market Checking. Motion carried unanimously.

Treasurers Report was given. Motion by Pinke and seconded by Steuart to approve the Treasurers report as read and printed. Motion carried unanimously.

Motion by Steuart and seconded by Pinke to adjourn meeting. Meeting closed at 11.00p.m.
