They are in the process of buying a few acres of land so they will own 15 acres. They now own 11 acres. The board told them they could not approve anything until they have a purchase agreement for the land they are purchasing.

Representatives from Biosolids Land Application appeared to explain their process of putting this on the fields owned by Beskau. They want to put the product on 160 acres on PID # 25-02000-25-010. They will do some water testing and report back.
